



TERMS OF SALE SEASON PASS COURMAYEUR, SEASON PASS MONT BLANC UNLIMITED AND PEDESTRIAN SEASONAL PASS ACCEPTED DURING PURCHASE.

DECLARATION OF ACCEPTANCE OF THE TERMS OF SALE

With this subscription, valid for the purchase of the aforementioned season ticket, I declare that I have fully read, understood and accept, also pursuant to and for the purposes of art. 1341 co. 1 of the Italian Civil Code, the ski resort Regulation and the conditions of sale contained therein as well as having read the information on the processing of personal data. The ski resort regulation is displayed and viewable at the ticket offices and on COURMAYEUR MONT BLANC FUNIVIE S.p.A. website.

OPENING GUARANTEE

With the sale of the seasonal skipass this company guarantees the opening for a minimum period of 90 days during the winter season. The start of the reference period corresponds to the opening day of the Courmayeur Mont Blanc Funivia ski area.

In the event that the competent authorities arrange for early closure of the ski areas, this skipass contract will be considered terminated. In this case, a portion of the seasonal skipass fee will be reimbursed proportional to the fewer days of opening compared to the 90 opening days guaranteed with the purchase of the season ticket.

In particular, I declare that I have read, understood and expressly accept, also pursuant to and for the purposes of Articles 1341 and 1342 of the Italian Civil Code as well as art. 33 Legislative Decree 2016/2005 (Codice del consumo), the following clauses contained in the Ski resort Regulation: 1) cap. 2 – Object (in particular: acceptance of the Regulation); 2) General provisions (in particular: exclusion of recourse); 3) Operational period (and particularly: indicative value of the exercise period; suspension of the exercise; exclusion of refund); 5) Lift operations (and in particular: time changes and exclusion of refunds); 6) Terms of use for the ski lifts (and in particular lett. g) and n): exclusion of liability; 10) Skipass: rates and terms of use (and in particular lett. e): exclusion of refund and lett. f): skipass non-transferable and withdrawal of seasonal skipasses); 12) Checks and sanctions (in particular lett. b): methods of checking seasonal skipasses; lett. e) and f): deactivation and sanctions in case of misuse) and Guarantee of opening.

ACCESS REGULATION

Access to the ski resort may be subject to health regulations issued by governmental authority.

OPENING GUARANTEE

With the sale of the seasonal ski pass, this company guarantees the opening of at least one station among those participating in the Valle d'Aosta ski pass for a minimum period of 130 days during the winter season, regardless of the actual use of the seasonal pass and from the opening period of the ski areas scheduled by the individual companies. In the event that the competent authorities arrange for early closure of the ski areas, this ski pass contract will be considered terminated. In this case, a portion of the seasonal ski pass fee will be reimbursed proportional to the fewer days of opening compared to the 130 opening days guaranteed with the purchase of the season ticket.

IMPOSITION OF A QUOTA OR RESTRICTIONS OF OPENING

Should the competent authorities arrange for the access to the ski areas to be restricted, the manager will be entitled to withdraw from this ski pass contract, reimbursing the unused portion in the manner provided for in the previous paragraph.

In particular, I declare that I have read, understood and expressly accept, also pursuant to and for the purposes of Articles 1341 and 1342 of the Italian Civil Code as well as art. 33 Legislative Decree 2016/2005 (Consumer Code), the following clauses contained in the Regulations: 4. Usability periods - 5. Conditions of use - 6 Rates (and in particular points 6.1 and 6.2.) - 7. Loss and theft, as well as: Access regulation, Opening guarantee, Imposition of a quota or restrictions of openings – 8. Checking and in particular the point 8.2.
